Denise Alter, Adjunct Professor, received her J.D. (1986) from USF. She practices at Shartsis, Friese & Ginsburg where she specializes in securities and general commercial litigation. Before becoming an attorney, she served as a Regional Labor Relations Executive for the U.S. Postal Service. Ms. Alter teaches Commercial Arbitration.

William Aseltyne, Adjunct Professor, received his J.D. (1990) *cum laude* from the University of Michigan where he was an editor of the Law Review, taught legal writing and oral advocacy, and founded the AIDS Law Clinic. He is Assistant Legal Counsel at California Pacific Medical Center in San Francisco. He also serves as President of the Board of Directors of Maitri AIDS Hospice and advises various nonprofit AIDS organizations. Mr. Aseltyne teaches Health Care Law and AIDS and the Law.

Michael W. Berwind, Adjunct Professor, received his J.D.
